**SUBJECT:** Nominations – Gateway Review Board

**SUMMARY:**

The Gateway Review Board reviews applications for building permits to erect, construct, renovate and/or alter an exterior of a building or sign located or to be located in the Gateway Review District. The Board is composed of seven (7) members appointed by the City Council. Three members must own property in the district; three members representing the architectural landscape, architectural, engineering, or building contracting profession (such member shall not own property within the district); one member at-large who does not own property in the district. The term of office is two years.

The term of all Board Members will expire June 30, 2014. All incumbents have indicated that they wish to be considered for reappointment. A list of the current members and their attendance records are attached for Council's review.

Nomination forms are attached for Council's use and should be submitted to the City Clerk's office by 5:00 P.M., Thursday, May 8, 2014 for consideration at the May 22, 2014 Council meeting.
