## DOCK POWER PERMIT APPLICATION

### GENERAL INFORMATION:

This application and affidavit is to be used for dock power on vacant lots where an approved and permitted dock has been constructed prior to a principle dwelling, or in cases where a dock has been approved and permitted for a lot where the waterfront portion is separated by road, other easement, or right of way.

### POLICY/PROCEDURE:

In granting Dock Power, the Contractor and owner must agree to the following:

- Electrical Contractor will only provide power for the dock, dock lighting, and lifts associated with the dock. The owner will maintain the temporary power pole in a safe manner until the Certificate of Occupancy for the principle dwelling is issued; or when a Certificate of Occupancy is not required, for the life of the dock.
- Owner shall not use the power pole for any other use than for the dock.

Violation will result in immediate shut-off of power and the owner must further agree that any violation may prohibit any future power being granted for the dock until the principle dwelling is constructed.

Therefore, the following procedure is hereby established to allow permitting of Dock Power:

- Submit completed and signed (**by both Owner and Electrical Contractor**) Dock Power Permit Application to the respective jurisdiction.
- The Dock Power Permit Application will not be accepted until the dock has been completed.
- The **DOCK POWER PERMIT DOES NOT AUTHORIZE ANY OTHER ACCESSORY USE OR STRUCTURE TO BE CONNECTED TO THE POWER POLE.**

*Note: The Building Officials may consider granting variations of this policy/procedure yet; variation from this policy/procedure will not be interpreted as setting precedence.*

This Permit **does not authorize any other connections than the dock power, dock lighting, and marine vessel lifts**. We understand and agree that the service to the dock will be immediately removed if it is determined that the power pole is ever connected to or supplying power for any unpermitted use.

We will maintain the Dock Power in a safe manner until the Certificate of Occupancy for a principle dwelling is issued, or when a Certificate of Occupancy is not required, for the life of the dock.

**VIOLATION** of this Agreement will justify immediate **TERMINATION** of Power and we further agree that violation of this Agreement may prohibit any future power being granted for the dock until a principle dwelling is constructed
