SUBJECT: Nominations – Fire Prevention Board

SUMMARY:

The Fire Prevention Board of Appeals was established by Council Ordinance as a Board of Appeals to review grievance regarding the decisions of the Fire Marshall.

The Fire Prevention Board of Appeals is composed of five members and two alternate members appointed by Council. Members shall have expertise in building construction and fire safety standards. No more than one of said members or their alternates shall be engaged in the same business, profession, or line of endeavor. ***THESE APPOINTEES ARE NOT REQUIRED TO BE CITY RESIDENTS.***

The term of Board Members Julian A. Harris and Robert Suhrheinrich will expire August 31, 2014. Both have indicated they would like to be considered for reappointment. These appointments/reappointments are for three (3) years, expiring August 31, 2017. There are also two vacancies on this board: Member – term expiring August 31, 2016 and Alternate – term expiring August 31, 2017. This Board meets on an as-needed basis.
