SUBJECT: Nominations – Architectural Review Board *ELB*

SUMMARY:

The Architectural Review Board approves or disapproves plans for buildings to be erected, renovated, or razed which are located, or to be located within the historic districts, preservation districts and Governmental Center District.

The Architectural Review Board is composed of seven members appointed by City Council, two from the West Florida Historic Preservation, Inc., each of whom shall be a resident of the City of Pensacola; one member from the City Planning Board or resident property owner of the Pensacola Historic District, North Hill Preservation District or Old East Hill Preservation District; two registered architects, each of whom shall be a resident of the City of Pensacola; one member who is a resident of the Pensacola Historic District, North Hill Preservation District or Old East Hill Preservation District; and one member who is a property or business owner in the Palafox Historic Business District or the Governmental Center District. These appointments are for a term of two years.

The term of Earle Bowden and Ben Townes, representatives of the West Florida Historic Preservation, Inc; and Michael Crawford and Carter Quina, registered architects, will expire September 30, 2014. Board Members Townes, Crawford, and Quina would like to be considered for reappointment. In addition, Julia Ussery, a property or business owner in the Palafox Historic Business District or Governmental Center District, has submitted her resignation and leaves an unexpired term that ends September 30, 2015.
