**SUBJECT:** Nominations – Human Relations Commission

**SUMMARY:**

The Human Relations Commission seeks to maintain positive human relations in Escambia County through resolution of civil rights related cases and incidents. It also administers the City's fair housing ordinance.

The Commission is composed of nine members. Four members are appointed by City Council, four members are appointed by the Board of County Commissioners and one member is appointed by the other eight members. Members serve for a term of two years. **MEMBERS ARE NOT REQUIRED TO BE RESIDENTS OF THE CITY.**

The term of Board Members Ryan Barnett and Augusta Simon will expire September 30, 2015. Both board members would like to be considered for reappointment.
